



Gan Clan Singapore Funeral Arrangement, Financial Assistance Provisions and Congratulatory Advertisement Guidelines

(A) Funeral Arrangement Guidelines

- 1.0 Purpose To enhance the relationship between Gan Clan Singapore and its members.
- 2.0 Entitlement
 - 2.1 Upon the demise of a Life Member:
 - 2.1.1 Gan Clan will send a wreath to express condolences.
 - 2.1.2 The deceased's family has to inform Gan Clan via phone, email or facsimile message with the deceased's membership number, address, contact phone number and death certificate etc.
 - 2.1.3 The deceased family has to notify the Secretariat two days prior to the funeral in order for any arrangements to be made.
 - 2.2 Upon the demise of member in the category comprising Honorary Advisors, Meritorious Life Presidents, Advisors, Honorary Life Presidents, Council Members from the last term, Current Council and Committee Members:
 - 2.2.1 Gan Clan will send a wreath to express condolences.
 - 2.2.2 The Secretariat would also inform the Council members accordingly to attend the wake on behalf of Gan Clan.
 - 2.2.3 When the spouse or parents of a Life Member in this category passes away, Gan Clan would accord the same courtesy to them. However, such courtesies will cease when the Life Member is deceased.
 - 2.2.4 Any donations made towards the deceased's family would be out of the donor's own free will. Donors could in turn donate these monies to Gan Clan on behalf of the deceased's family.
 - 2.2.5 If the deceased's family would like to put up a condolence announcement bearing Gan Clan Singapore's name, the family will bear the full cost of the advertisement.
 - 2.2.6 Placement of condolence announcement must adhere to the content and format guidelines as specified by Gan Clan with the content approved by the Secretariat which would also be the liaison contact.
 - 2.3 Upon the death of Honorary Advisor, Meritorious Life President, Advisor and President, the entitlement would be in accordance with (A) 2.2. In addition,
 - 2.3.1 Gan Clan will place a quarter-page condolence announcement in the local Chinese newspaper.



(B) Financial Assistance Provisions Guidelines

| 2.0 | Purpose | To assist the Gan clansmen who are elderly, poor/destitute, sick or unemployed. |
| 3.0 | Application | Gan Clan members and their immediate families are eligible to apply. Disbursement and amount of financial assistance is determined and dependent upon review of each case. |
| 4.0 | Entitlement | For emergency cases, the Honorary Secretary could give approval for financial assistance up to a maximum of S\$200 without having to seek the approval of the Council. |
| 5.0 | Funding | Source of Funds |
| | 5.1 | Gan Clan could seek and source for donations from clansmen |
| | 5.2 | The Council could decide if Gan Clan should tap on its accumulated funds. |
